a. **Roadway Re-surfacing:**

AN ADDITIONAL THREE PERCENT (3%) SURCHARGE IS LEVIED ON ALL CHARGES LISTED IN SECTIONS 1 THROUGH 5 INCLUDING ALL BASE AND GALLONAGE CHARGES EXCLUDING 1c, 2d and 3b AND SECTION C 1 TO FUND ROADWAY RE-SURFACING. A water rate surcharge is levied to finance the costs of roadway re-surfacing at the end of each neighborhood's construction for the Septic Tank Replacement Program (STRP). Total surcharge of three percent (3%); levied two percent (2%) in February 2007, October 2007, October 2008, and reduced by 2% in November 2011, and reduced by 1% in March 2012. Surcharge will remain in place until all costs of roadway re-surfacing have been recovered.

b. **Septic Tank Replacement Program (STRP):**

AN ADDITIONAL THREE PERCENT (3%) SURCHARGE IS LEVIED ON ALL CHARGES LISTED IN SECTIONS 1 THROUGH 5 INCLUDING ALL BASE AND GALLONAGE CHARGES EXCLUDING 1c, 2d and 3b AND SECTION C 1 TO OFFSET COSTS OF

SEPTIC TANK REPLACEMENT PROGRAM (STRP). A water rate surcharge is levied to finance the costs of reducing the neighborhood construction charge for the STRP in the amount of \$2,758 per property. Cost reduction is the net present value of payments in monthly sewer user fees for upgrading the existing wastewater utility plant. Water rate surcharge in the amount of three percent (3%) implemented October 2007 and reduced by 5% in March 2012.

(7) After Hours - For services identified in footnotes (1) through (6) above, a \$75.00 per occurrence fee will be applied for services rendered outside of normal business hours of 8 AM to 4 PM daily, Monday through Friday, excluding scheduled holidays.
