

RESOLUTION NO. 14-03

A RESOLUTION TO REVISE EXISTING FEES RELATED TO ACTIVITIES AND DEVELOPMENT WITHIN THE PUBLIC RIGHTS-OF-WAY, AMENDING THE FEES SCHEDULE PROVIDED FOR IN THE CITY OF MARCO ISLAND CODE OF ORDINANCES, CHAPTER 42, STREETS, SIDEWALKS AND OTHER PUBLIC PLACES, ARTICLE III TO PROVIDE FOR PARKING FEES AND SIDEWALK REPAIR FEES; PROVIDING FOR INCORPORATION, CONFLICT AND SEVERABILITY, AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, Section 42-76(c) provides for payment of the applicable permit fees established by resolution of the City Council; and

WHEREAS, City Council is authorized to amend, modify, or otherwise change, delete or add to the listed fees by resolution; and

WHEREAS, all other sections of Chapter 42, Streets, Sidewalks and other Public Places adopted by ordinance remain in effect.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MARCO ISLAND, FLORIDA:

Section 1 In accordance with the provisions of Code, the underlined charges identified on "Exhibit A" for parking and sidewalk repairs shall be adopted.

Section 2. Incorporation, Conflict, and Severability.


- (1) It is the intention of the City Council and it is hereby resolved that the provisions of this resolution shall become and be made a part of the Code of Ordinances of the City of Marco Island, Florida, and that the sections of Chapter 42 may be renumbered or relettered and that the word "ordinance" may be changed to "section," "article," or other appropriate word.
- (2) All sections or parts of sections of the Code of Ordinances of the City of Marco Island, all ordinances or parts of ordinances, all resolutions or parts of resolutions, in conflict herewith, be and the same are hereby repealed to the extent of the conflict.
- (3) If any word, phrase, clause, subsection, or section of this resolution is for any reason held unconstitutional or invalid by a court of competent jurisdiction, the invalidity thereof shall not affect the validity of any remaining portions of the resolution.

Section 3. Effective Date.

This Resolution shall take effect immediately upon adoption.





DEVELOPMENT ACTIVITIES WITHIN PUBLIC RIGHTS-OF-WAY

TYPE OF FEE

Leased Parking on Any City Owned Property, Except the Public Rights-of-Way. \$8.00 per day or any portion thereof

Right of Way Construction Permit Fee

Sidewalk Repair \$50.00 (less than 15 linear feet)

Residential \$200.00

Non-Residential From \$1,000.00 (small) to \$4,000.00 (large)

Reconstruction from Swale to Culvert Driveway Or Reconstruction of Existing

Residential \$200.00

Commercial \$250.00

Right-of-Way Construction Permit Removal Fee

Residential \$150.00

Non-Residential \$500.00 (small) to \$1,000.00 (large)

Jack and Bore / Directional Bore

Residential \$500.00

Non-Residential \$1,000.00 (small) to \$2,000.00 (large)

Open Cut Construction Fee

Residential \$2,000.00

Non-Residential \$4,000.00 (small) to \$6,000.00 (large)

PCS Regulated by City Franchise Utility fee (Yearly Blanket)

\$500.00 Plus \$50.00 Per Day Inspection Fee

Landscape Improvement in City Right-of-Way

Non-Residential	\$400.00

Turn Lane / Median Construction Fee

Residential	\$500.00
Non-Residential	\$2,000.00 (small) to \$3,000.00 (large)

After-the-Fact Permit Fee
Four (4) Times North Fee
\$2,000.00 Maximum

INSPECTION FEES

	\$50.00 Each
1 st Re-inspection Fee	\$100.00
2 nd Re-inspection Fee	\$150.00
3 rd Re-inspection Fee	\$200.00
Each Inspection After 3 rd	\$250.00
Non-Residential	\$2,000.00 (small) to \$3,000.00 (large)

NOTES:

- Blanket Utility Fee does not apply over 300 LF of installation
- Small and Large based on drainage impacts and square footage of ROW impacted
Up to 450 sq. ft. (small) over 450 sq. ft. (large)
