RESOLUTION 09- 15

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MARCO ISLAND, FLORIDA AMENDING RESOLUTION 08-24 TO UPDATE ITS ESTABLISHED RULES AND POLICIES TO APPLY TO OFF-LEASH DOG ACTIVITIES IN IDENTIFIED CITY DOG PARKS; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the City of Marco Island adopted Article I, Section 34-1, entitled the “Parks and Recreation Rules Ordinance,” for the purpose of providing necessary regulations, conditions, and requirements which shall be uniformly applied to the general public’s use of city owned parks; and

WHEREAS, two new City dog parks will soon be open for the use and enjoyment of the public and City Council desires to identify these City dog parks by resolution as required by Section 34-3(k)(2); and

WHEREAS, the City Council desires to update its established policies and rules regarding dogs in City parks to create additional policies and rules regarding permissible and prohibited off-leash activities in City dog parks, as provided in Section 34-3(k)(1).

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF MARCO ISLAND, FLORIDA, AS FOLLOWS:

SECTION 1. Recitals.

The foregoing “Whereas” clauses are hereby ratified and confirmed as being true, correct and incorporated into this Resolution.

SECTION 2. Policies and Rules.

1. Rule and policy (c) in Resolution 08-24 shall be amended to read as follows:

(c) Dogs shall be kept on a leash restraint at all times while in the City parks, except in identified City dog parks.

2. Items (l) – (o) shall be added to the rules and policies contained in Resolution 08-24 to read as follows:

(l) Persons in possession of a dog(s) in a City dog park shall not allow the dog(s) to run along the perimeter of the City dog park in a manner that annoys or is disruptive to the quiet enjoyment of neighboring property owners or others using adjacent city sidewalks.

46 (m) Persons in possession of dog(s) that are off-leash in a City dog park shall maintain
47 supervision of the animal(s) at all times.

48
49 (n) By allowing their dog(s) to enter a City dog park, the owner consents and agrees to be
50 financially responsible for any damage or injury caused by the dog(s) to trees,
51 landscaping or other City property.

52
53 (o) All dog(s) using a City dog park must have a current dog tag and evidence of
54 vaccination or the dog(s) must be immediately removed from the dog park.

55
56 **SECTION 3. Permitted City Parks.**

57
58 The list of parks in Resolution 08-24 that allow dog(s) shall be amended to
59 include the following:

61 "Canine Cove" also known as Mackle Park Big and Small Dog Park illustrated in
62 Exhibit "A"


