## RESOLUTION NO. 08-15

### A RESOLUTION TO COMMEND E. GLENN TUCKER FOR HIS SERVICE ON THE MARCO ISLAND CITY COUNCIL

WHEREAS, the City of Marco Island incorporated on August 28, 1997; and

WHEREAS, on November 11, 1997, E. Glenn Tucker was elected by the people of Marco Island to serve on the first Marco Island City Council, following decades of volunteer work and community involvement with many civic groups, his church, the YMCA, and the Marco Island Area Association of Realtors; and

WHEREAS, E. Glenn Tucker served on the Marco Island City Council until March 17, 2008, the first elected official to serve for ten years, and the only remaining Councilor from the first elected City Council of 1997; and

WHEREAS, E. Glenn Tucker utilized his vast legal knowledge and experience during the formative period of Cityhood to firmly establish a new local government and the service it provides to the people of Marco Island; and

WHEREAS, E. Glenn Tucker has excelled in his analysis of issues and his articulation of alternatives for consideration by his colleagues on City Council, while ensuring full compliance with the spending cap, local, state, and federal law; and

WHEREAS, E. Glenn Tucker was selected by his colleagues to represent City Council on the Collier County Tourist Development Council and the Coastal Advisory Committee, each requiring a commitment to prepare for and attend countless meetings during his tenure; and

WHEREAS, E. Glenn Tucker was elected by his colleagues to serve as Council Chair in 2001 and again in 2002, a time period that required and benefited from his exceptional leadership skills, his "Can Do" attitude, and his commitment to new policies beneficial to the people of Marco Island; and

WHEREAS, E. Glenn Tucker will be remembered for being the longest serving Councilman in the history of Marco Island and the countless hours he has devoted in service of his community.

NOW, THEREFORE, BE IT RESOLVED, by the City Council of Marco Island, Florida, that E. Glenn Tucker is hereby commended for his outstanding service to the people of Marco Island since the City's incorporation in 1997 and throughout his term on the Marco Island City Council.

BE IT FURTHER RESOLVED that the Marco Island City Council extends its sincerest gratitude and appreciation to E. Glenn Tucker for his outstanding contributions to the City of Marco Island.
