**A RESOLUTION OF THE CITY OF MARCO ISLAND, FLORIDA
AMENDING EXHIBIT "A" UTILITY RATE SCHEDULE TO ORDINANCE
2003-19; AND PROVIDING AN EFFECTIVE DATE.**

WHEREAS, Section 3 of Ordinance 2003-19 provides that rates, fees, and charges shall be reviewed and adjusted by resolution.


NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Marco Island, Florida:



6. RATE SURCHARGES:

Water rates include a surcharge to finance the costs of roadway re-surfacing at the end of each neighborhood's construct for the Septic Tank Replacement Program (STRP). Total surcharge eight percent (8%); levied two percent (2%) in Febru 2007, October 2007, October 2008, and October 2009. surcharge will remain in place until all costs of roadway re-surfac have been recovered.

Water rates include a surcharge to finance the costs of reducing the neighborhood construction charge for the STRP in th amount of \$2,758 per property. Cost reduction is the net present value of payments in monthly sewer user fees for upgra the existing wastewater utility plant. NOTE 1: Effective January 1, 2009, Reclaimed water will be priced at 40% of Potable Water (\$1.44 per 1,000 gallons) for all customers with the exception of customers with properly permitted privately-owned lakes that will accept Reclaimed Water at Utility's request. Reclaimed water fees for those accounts will continue at 30% of Potable Water (\$1.08 per 1,000 gallons).

NOTE 2: Effective October 1, 2007, all new customers connected to Reclaimed Water system will be charged the rate for potable water per this schedule for twenty-four (24) months, to provide for recovery of capital investment costs of expanding the Reclaimed Water distribution system.
