

MARCO ISLAND PLANNING BOARD RESOLUTION NO. 03-54

RELATING TO PETITION NUMBER TUE-03-02 FOR AN EXTENSION OF A TEMPORARY USE PERMIT FOR A MODEL HOME ON PROPERTY HEREINAFTER DESCRIBED IN CITY OF MARCO ISLAND, FLORIDA.

WHEREAS, the Legislature of the State of Florida established the Charter of the City of Marco Island in Chapter 97-367, Laws of Florida ("City Charter"); and

WHEREAS, the City Charter provides that there shall be a planning commission advisory to the City Council; and

WHEREAS, the City Council adopted Ordinance 98-1, establishing and creating the Marco Island Planning Board; and

WHEREAS, pursuant to Ordinance No. 98-1, the Marco Island Planning Board is responsible for reviewing and finally approving temporary use permit extensions; and

WHEREAS, Petition TUE-03-02 is a request for a temporary use permit extension as defined in Ordinance 98-1; and

WHEREAS, the City of Marco Island has adopted Ordinance 02-15 which regulates temporary use permits, including model home permits; and

WHEREAS, the Marco Island Planning Board, being the duly constituted Planning Board for the area hereby affected, has held a public hearing after proper notice as provided in said Regulations was made, and has considered the advisability of a 6 month extension of a temporary use permit for a model home in a RSF-4 zone for the property hereinafter described, and has found as a matter of fact that satisfactory provision and arrangement have been made concerning all applicable matters required by said regulations and in accordance with Section 30-794 of the City of Marco Island Code of Ordinances; and

WHEREAS, all interested parties have been given the opportunity to be heard by this Commission in public meeting assembled, and the Commission having considered all matters presented;

NOW THEREFORE, BE IT RESOLVED BY THE CITY OF MARCO ISLAND PLANNING BOARD of the City of Marco Island, Florida that:

The petition filed by Don Donner of Enterprise Construction with respect to the property hereinafter described as:

Marco Beach Unit 7, Block 205, Lot 27, Collier County, and within the City of Marco Island, Florida


Be and the same is hereby approved for a 6 month extension of a temporary use permit for a model home in a RSF-4 zoning district where in said property is located.

This resolution adopted after motion, second and majority vote.


