ORDINANCE NO. 99- 21

AN ORDINANCE AMENDING THE BUDGET FOR THE CITY OF MARCO ISLAND FOR THE FISCAL YEAR COMMENCING OCTOBER 1, 1998, AND ENDING SEPTEMBER 30, 1999.

WHEREAS, the City of Marco Island adopted Ordinance No. 98-15, the City Budget, on September 21<sup>st</sup>, 1998, and Ordinance No. 99-06, amending the City Budget, on April 19<sup>th</sup>, 1999; and

WHEREAS, the City of Marco Island has established standard procedures for budget amendments to control the integrity of the budget; and

WHEREAS, the City of Marco Island has performed a final budget review for fiscal year 1998-99 to evaluate the annual budget for changes needed; and

WHEREAS, City Council so desires to amend the 1998-99 budget,

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MARCO ISLAND, FLORIDA THAT:

Section 1. Ordinance No. 99-06, amending the budget for the fiscal year commencing October 1, 1998, and ending September 30, 1999, shall be further amended as provided in the attached Exhibit "A" and incorporated herein.

Section 2. This Ordinance shall take effect immediately upon approval by the Marco Island City Council at second reading.

Passed in open and regular session through roll call vote by the City Council of the City of Marco Island, Florida, this 18th day of October, 1999.


