

ORDINANCE NO. 99-13

AN ORDINANCE AMENDING ORDINANCE 98-20 BY CORRECTING AN OMISSION TO THE LEGAL DESCRIPTION OF THE PIER 81 PUD, AND BY PROVIDING AN EFFECTIVE DATE.

WHEREAS, on September 21, 1998 City Council adopted second reading of Ordinance 98-20 which changed the zoning classification of approximately 5.87 acres of real property to PUD (Planned Unit Development); and

WHEREAS, in subsequent review of the adopted ordinance a scrivener's error/omission has been discovered in regard to the lots identified in the ordinance; and

WHEREAS, the purpose of this ordinance is to correct the omission to fully describe the property which comprises the acreage of the previously approved Pier 81 PUD.

NOW, THEREFORE, BE IT ORDAINED by the City Council of Marco Island, Florida:

SECTION ONE:

That the description of the property contained in Ordinance 98-20 be amended to read as follows:

All of lots 3, 4, 5, 6, 7, 8, 9, 10, 11, 12, 13, and 14, Block 19, and all of lot 49, block 18 according to the amended plat of Collier City recorded in plat book 1, page 58, all of lots 1, 2, 3, 4, 5, 6, 7, 8, 9, 10, block 4, according to the plat of Old Marco Village as recorded in plat book 6, page 3, all of lot 1, block 134, according to the plat of Marco Beach Unit Four, as recorded in plat book 6, pages 32 through 37, and including vacated portions of Jackson Avenue and Bald Eagle Drive, in section 5, township 52 south, range 26 east, Marco Island, Florida.

Said property is further described in Exhibit "B", which is attached.


SECTION TWO:






