

RESOLUTION NO. 99-40

**A RESOLUTION TO REVISE THE SCHEDULE OF FEES
RELATED TO DEVELOPMENT ACTIVITIES WITHIN THE
PUBLIC RIGHTS-OF-WAY; AND PROVIDING AN
EFFECTIVE DATE.**

WHEREAS, Ordinance 98-17 serves as the Administrative Construction Code for the City of Marco Island; and

WHEREAS, said Ordinance provides that a schedule of permit fees for various categories of construction activities may be amended by Resolution; and

WHEREAS, City Council adopted Resolution No. 98-33 to amend right-of-way permit fees; and

WHEREAS, City Council desired to amend the permit fees to provide a financial incentive to complete work in a timely manner.

NOW, THEREFORE, BE IT RESOLVED, by the City Council of the City of Marco Island, Florida that:

Section 1. Right-of-Way Permit and Inspection Fees are amended as follows:

Right-of-Way (ROW) Permit and Inspection Fees:

Right-of-Way Construction Permit fee	\$125
Reconstruction from swale to culvert driveway or reconstruction of existing culvert driveway	\$ 65
Right-of-Way Construction Permit Removal fee	\$ 45
Jack-and-bore fee	\$170 +*
Open-cut construction fee	\$235 +*
PSC regulated or City Franchise Utilities fee	\$ 85 +*
Sprinkler Head Placement in City ROW fee	\$ 25
Landscape Improvement in City ROW fee	\$ 65
Turn-lane/median construction fee	\$125 +*
After-the-fact permit fee	4 times normal fee \$1000 max.

Reinspection Fees:

1 st	\$45
2 nd	\$50
Each inspection after 2 nd	\$65

*NOTE 1: In addition to the right-of-way permit application fee, the applicant shall pay a \$50.00 per-day inspection fee based on the number of work days as determined by the engineer or agent of record. Any extension of the permitted time period shall result in a continuation of the per-day inspection fee. Right-of-way permits limited to the authorization of single-family driveway connections and landscape and sprinkler head placement shall be exempt from the inspection fee.

NOTE 2: If there are multiple right-of-way improvements associated with a project site, the highest fee will apply.

Section 2. EFFECTIVE DATE. This Resolution shall take effect immediately upon its adoption.


