

RESOLUTION NO. 98-13

A RESOLUTION OF THE CITY OF MARCO ISLAND, FLORIDA, REQUESTING MEMBERSHIP IN THE NAPLES-COLLIER COUNTY METROPOLITAN PLANNING ORGANIZATION; PROVIDING FOR DISTRIBUTION OF THIS RESOLUTION; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the Section 339.175(2), Florida Statutes, authorizes the Governor to determine the number of members of the Naples-Collier County Metropolitan Planning Organization; and

WHEREAS, membership is especially important to newly established municipalities who must place greater emphasis on planning; and

WHEREAS, Marco Island officially became Collier County and Florida's newest city as of August 28, 1997, and the newly incorporated City of Marco Island has a permanent population of 13,490 and is not currently a member of the Naples-Collier County Metropolitan Planning Organization.

NOW, THEREFORE, be it resolved by the City Council of the City of Marco Island, Florida:

SECTION 1. REQUEST FOR MEMBERSHIP.

The City Council hereby requests that the Governor add to and reapportion the membership of the Naples-Collier County Metropolitan Planning Organization and to include a representative of the City of Marco Island as a member.

SECTION 2. DISTRIBUTION.



SECTION 3. EFFECTIVE DATE.


This Resolution shall become effective upon its adoption.


